1 NOTICE OF RULING

2 On June 24, 2020, the parties appeared at a Status Conference, the Honorable William F.
3 Highberger, Judge presiding. The parties stated their appearances on the record. The Court
4 reviewed the papers and made the following orders.

5 The Court discussed Defendant and Cross-Complainant City of San Buenaventura's
6 ("City") Ex Parte Application for Extension of Time to File Proof of Service. No party opposed
7 the application, and the Court granted the request, extending the time for City to file proofs of
8 service of its Third Amended Cross-Complaint until October 1, 2020.

9 The Court ordered Mr. Hagerty, counsel for the City, and Mr. Cooper, counsel for Santa
10 Barbara Channelkeeper ("Channelkeeper"), to meet and confer regarding Channelkeeper's
11 potential motion practice before July 4, 2020 and to post a message for the Court by July 7, 2020
12 as to whether setting a hearing date on Channelkeeper's motion is necessary.

13 The Court set a further Status Conference for August 17, 2020, at 1:30 p.m., and ordered
14 that a Joint Report to be filed and served by August 10, 2020. At the further Status Conference, a
15 group of consumptive users will propose a schedule for the parties and the Court to consider a
16 stipulated judgment and physical solution. The parties will meet and confer regarding this
17 schedule in advance of the filing of the Joint Report. As part of this process, the parties will
18 discuss, among other things, extending the deadline to respond to the City's Third Amended
19 Cross-Complaint and the deadline to provide initial disclosures.
