STATUS CONFERENCE REPORT

Defendant and Cross-Complainant City of San Buenaventura (City) submits this Status

Conference Report (Report) in advance of the Status Conference scheduled for May 10, 2021 at 1:30 p.m. In accordance with the Court's discussion at the April 19, 2021 Status Conference, the City has made a good faith effort to solicit input from interested parties prior to submission of this Report. Specifically, counsel for the City sent a draft of this Report via email to all counsel of record and to all parties for which the City has an email address on April 28, 2021 and invited input. The City received comments from Cross-Defendant Claude Baggerly and accommodated his requested revisions in section 5 below. The City understands that some parties may submit their own Status Conference Reports.

Subject to the Court's direction and needs of the other parties, the City anticipates that the May Status Conference will be fairly narrow in scope, with a much more significant discussion occurring at the June 21, 2021 Status Conference.

1. ORDER TO SHOW CAUSE REGARDING SERVICE BY PUBLICATION

The Court set an Order to Show Cause (OSC) hearing regarding service by publication of the summons for the May 10, 2021 Status Conference. On April 16, 2021, the City filed an application for an order to serve via publication for the 51 Cross-Defendants that are behind fences and gates. In advance of the May 10, 2021 Status Conference, and consistent with the discussion with the Court at the April Status Conference, on April 28, 2021, City sent Notice and Acknowledgment of Receipt forms with complete service packets of the Third Amended Cross-Complaint (Cross-Complaint) to 51 unserved Cross-Defendants. The City will file the Notice of OSC, a declaration in support of the OSC, and a [Proposed] Order for Publication on May 5, 2021.

2. MEET AND CONFER RE CITY MOTION

The City has scheduled an all-parties Zoom meet and confer session on May 6, 2021 at 10:00 a.m. regarding its proposed motion to bifurcate set for hearing on June 21, 2021 at 1:30 p.m. The City will update the Court regarding these meet and confer efforts at the May 10, 2021 Status Conference.

3. UPDATE RE SERVICE OF THE THIRD AMENDED CROSS-COMPLAINT

The City diligently continues to work to complete service of the Cross-Complaint on all named Cross-Defendants, including newly added Roes. The City continues to make substantial progress on these efforts.

As of the last Status Conference, there were 102 unserved Cross-Defendants out of the over 2,500 Cross-Defendants named in the Third Amended Cross-Complaint. The City has attempted to serve by notice and acknowledgment of receipt packages by overnight mail to the 51 Cross-Defendants behind gates and fences. Those Cross-Defendants that do not timely return the acknowledgment of receipt will be served via publication, if the Court so orders. The City successfully served 5 additional Cross-Defendants in April and early May and continues its efforts to serve the remaining 46 that are not behind gates and fences. Summary tables are provided below. The City will continue to attempt to locate and serve these un-served Cross-Defendants, including by conducting targeted outreach and phone calls to and additional researching and tracking of un-served Cross-Defendants.
