
IT IS ORDERED that an Order to Show Cause hearing be set for September 20, 2021 at 9:00 a.m. in Department S10 of the Los Angeles County Superior Court, located at 312 North Spring Street, Los Angeles, CA 90012. The Order to Show Cause will address service of the summons in this action to be made upon each of the heirs and devisees of certain deceased Cross-Defendants, and two unserved Cross-Defendants behind gate and fence, as identified in the attached Exhibit "A." Service on the heirs and devisees and on Cross-Defendant Ole Behrendtsen shall be by publication thereof in the *Ventura County Star*, a newspaper of general circulation, and serving the County of Ventura, California, and that said publication be made at least once a week for four successive weeks. Service of Cross-Defendant Shanks Investment Group, LLC shall be by service on the Secretary of State.

IT IS ORDERED that Cross-Complainant CITY OF SAN BUENAVENTURA is excused from delivering a copy of this Order for Service by Publication or the Summons and Third Amended Cross-Complaint to each such heirs and devisees as their identities are unknown to Cross-Complainant.

IT IS ORDERED that Cross-Complainant CITY OF SAN BUENAVENTURA will overnight mail a copy of this Order setting an Order to Show Cause hearing on Cross-Defendants Ole Behrendtsen and Shanks Investment Group, LLC, a proposed order for service by publication and service of Summons by delivery to the Secretary of State, notice and acknowledgment of receipt with a self-addressed, stamped envelope, along with a full service package including a copy of the Summons and Third Amended Cross-Complaint, no later than August 24, 2021. If there is any opposition to the issuance of such Order, written opposition must be filed and served in advance of the Order to Show Cause hearing.
