1 I, Marnie A. Prock, declare and state as follows:

2 1. I am over the age of eighteen years and a senior paralegal employed by the law  
3 firm of Best Best & Krieger LLP (“BBK”), attorneys of record for Respondent and Cross-  
4 Complainant, City of San Buenaventura (“CITY”) in the above-entitled action (“Action”).

5 2. I have been a paralegal in California for more than 21 years and have held various  
6 positions in two of California’s largest and most historic public law firms for more than 31 years.  
7 I have been employed by BBK since September, 2010.

8 3. My day to day activities include all facets of litigation, including research related  
9 to real property ownership, analyzing deeds and title reports, locating individuals and corporate  
10 entities for service of process, researching probate records for heirs and devisees, analyzing  
11 policy and procedures relating to court filings and processes, and seeking orders for publication  
12 and posting of summons when necessary for quiet title, title defect, eminent domain and  
13 prescriptive rights cases.

14 4. Each of the facts stated herein is within my personal knowledge, and I would so  
15 testify if called as a witness at any hearing.

16 5. In an effort to locate potential parties with interests at issue in this Action, I  
17 conducted extensive research into the real property record databases of the following reputable  
18 and well known title companies: Fidelity National Title Insurance Company, First American Title  
19 Insurance Company, and Chicago Title Insurance Company. In searching these databases, I  
20 identified any additional interested persons or entities, of which the CITY had a duty to serve the  
21 Summons and Third Amended Cross-Complaint.

22 6. On or about November 21, 2019, CITY engaged Process Server One (“PSO”) to  
23 personally serve nearly 2,600 Cross-Defendants.

24 7. On or about January 2, 2020, CITY filed its Third Amended Cross Complaint  
25 which named each Cross-Defendant who holds any property interests which are subject to the  
26 Action and proceeded to personally serve each Cross-Defendant.

1           8.       On or about August 24, 2020, I and BBK staff that I work with and oversee started  
2 preparing notices of acknowledgment of receipt and personalized letters, and we proceeded to  
3 mail serve each unserved Cross-Defendant. In addition, I researched any returned mailings to try  
4 to ascertain current addresses and/or the status of each returned envelope.

5           9.       On or about November 2, 2020, I and the BBK staff that I work with and oversee  
6 received Tax Assessor records for each Cross-Defendant. I and BBK staff that I work with and  
7 oversee used the Tax Assessor records to cross-check mailing addresses of the most recent tax  
8 bills for each unserved Cross-Defendant.

9           10.      On or about December 1, 2020, I and the BBK staff that I work with and oversee  
10 prepared a follow up mailing of notices of acknowledgement of receipt to each unserved Cross-  
11 Defendant, including those that are the subject of this request order to serve the Secretary of State  
12 for California corporations in which service has been unsuccessful on both the Agent for Service  
13 of Process and the location of the business as gleaned from the records online at the Secretary of  
14 State website at <https://businesssearch.sos.ca.gov/>. True and correct copies of the records relied  
15 upon for each of the California corporations are attached hereto and incorporated herewith as  
16 Exhibit "A." In addition, I again researched any returned mailings to try to ascertain current  
17 addresses and/or status of each returned envelope.

18           11.      On or about January 28, 2021, I, on behalf of BBK, engaged a different process  
19 server, First Legal, to personally serve approximately 319 unserved Cross-Defendants. Even  
20 though PSO had previously been unsuccessful in serving these unserved Cross-Defendants, I and  
21 BBK staff that I work with an oversee tasked First Legal with attempting service on those Cross-  
22 Defendants again in the hopes that First Legal may have some success where PSO had not been  
23 able to effect service.

24           12.      There are an additional seven corporations in which the CITY is requesting an  
25 order to allow service on the Secretary of State either because the Agent for Service of Process is  
26 deceased with no known successor Agent to serve or the corporations are defunct or suspended.  
27 A true and correct copy of the list of unserved California corporations along with the reason for  
28 unsuccessful service is attached hereto and incorporated herewith as Exhibit "B."

1           13.     Over the course of the last several months, First Legal attempted to serve all  
2 unserved Cross-Defendants at all addresses listed on the Secretary of State website including  
3 those addresses the entity was located. In addition, I personally performed research both on real  
4 estate databases to ensure the property was still owned by the entity and on TLO to determine if  
5 either the entity or the Agent for Service of Process was at a different address. As shown on  
6 Exhibit B, most agents were deceased and the entity was not at the location as reported on the  
7 Secretary of State website.

8           14.     Despite several attempts of personal service and mail service over the course of the  
9 past year and a half the seven California corporation remain unserved. True and correct copies of  
10 the diligence reports for these seven Cross-Defendant California corporations is attached hereto  
11 and incorporated herewith as Exhibit "C."

12           I declare under penalty of perjury under the laws of the State of California that the  
13 foregoing is true and correct, and that this declaration was executed on June 17, 2021, at  
14 Stockton, California.
