15 The type of water right or rights claimed by the party for the extraction of groundwater.

16 **RESPONSE TO DISCLOSURE NO. 3:**

17 Friends Stable & Orchard, Inc. is an overlying landowner and asserts both overlying and  
18 unexercised water rights for the extraction of groundwater from a water well located on its  
19 property from the Ojai Groundwater Basin.

20 Friends Stable & Orchard, Inc. also asserts a right to use groundwater under the self-help  
21 doctrine, if prescriptive rights to extract groundwater from the basin are determined.

22

23 **DISCLOSURE NO. 4:**

24 A general description of the purpose to which the groundwater has been put.

25 **RESPONSE TO DISCLOSURE NO. 4:**

26 Friends Stable & Orchard, Inc. extracts and uses groundwater from the Ojai Groundwater  
27 Basin for irrigated agriculture on its land to grow Valencia and Navel oranges, as well as Pixie  
28 Mandarin tangerines, and other reasonable and beneficial uses of water.

17 parcels are supplied by a single well within the Ojai Basin Groundwater Management Area  
18 (OBGMA).

20 **DISCLOSURE NO. 7:**

21 Any claims for increased or future use of groundwater.

22 **RESPONSE TO DISCLOSURE NO. 7:**

23 Friends Stable & Orchard, Inc. anticipates that its future use of groundwater will be  
24 within the same range as its current use.

25 Friends Stable & Orchard, Inc. asserts the maximum historical right to pump and  
26 consumptively use groundwater (whether dormant or currently unexercised, which is never lost,  
27 forfeited, or abandoned for any period of non-use) or due to any shift in future irrigated  
28 agriculture crop production.

1 Friends Stable & Orchard, Inc. reserves the right to supplement this initial disclosure with  
2 additional future uses.

3  
4 **DISCLOSURE NO. 8:**

5 The quantity of any beneficial use of any alternative water use that the party claims as its  
6 use of groundwater under any applicable law, including, but not limited to, Section 1005.1,  
7 1005.2, or 1005.4 of the Water Code.

8 **RESPONSE TO DISCLOSURE NO. 8:**

9 To the extent that Friends Stable & Orchard, Inc. may have a riparian right to subsurface  
10 underflow that is “part and parcel” of the property, it reserves the right to this additional water  
11 use pursuant to Water Code Sections 1005.1, 1005.2, 1005.4, or other applicable law.

12 Friends Stable & Orchard, Inc. also asserts any quantity of water used as a metered  
13 customer of Casitas Municipal Water District (by any source of its own surface of groundwater  
14 right(s) of its own) as an alternative source that it might use on any of its property *in lieu of* or as  
15 a supplement to any right of use that it might otherwise use to a maximum reasonable and  
16 beneficial use for domestic potable uses.

17  
18 **DISCLOSURE NO. 9:**

19 Identification of all surface water rights and contracts the party claims provides the basis  
20 for its water right claims in the comprehensive adjudication.

21 **RESPONSE TO DISCLOSURE NO. 9:**

22 Friends Stable & Orchard, Inc. asserts riparian surface rights to McNell Creek, and  
23 possible riparian rights to subsurface underflow underneath any of its property.

24 Friends Stable & Orchard, Inc. also asserts the annual quantity of water used as a metered  
25 customer of Casitas Municipal Water District which it might otherwise use *in lieu of* any  
26 separate right of use it has to either riparian surface water or overlying landowner groundwater.

1 **DISCLOSURE NO. 10:**

2 The quantity of any replenishment of water to the basin that augmented the basin's native  
3 water supply, resulting from the intentional storage of imported or non-native water in the basin,  
4 managed recharge of surface water, or return flows resulting from the use of imported water or  
5 non-native water on lands overlying the basin by the party, or the party's representative or agent,  
6 during each of the 10 calendar years immediately preceding the filing of the Complaint.

7 **RESPONSE TO DISCLOSURE NO. 10:**

8 Friends Stable & Orchard, Inc. does not currently import any non-native water, but  
9 reserves all rights to drill a deep well into the fractured bedrock beneath the alluvial soils of the  
10 groundwater basin, which would not be hydrologically connected to any surface or subsurface  
11 flows.

12 Friends Stable & Orchard, Inc. does not currently import any non-native water or manage  
13 any recharge of surface water peak-flow into groundwater, but it reserves the right to appropriate  
14 water and store such waters for more than 30-days (pursuant to a Water Availability Analysis)  
15 and/or capture and store stormwater or rainwater.

16 Friends Stable & Orchard, Inc. reserves the ability to generate any combination of offsets  
17 or production forbearance or conserved water credits that might otherwise contribute to either  
18 onsite water supply resiliency and reliability or enhance stream flow.

19 Friends Stable & Orchard, Inc. is exploring the use of mulch in its orchard to further  
20 conserve water and reduce onsite annual demand and pumping.  
21




