1 I, Marnie A. Prock, declare and state as follows:

2  
3 1. I am over the age of eighteen years and a senior paralegal employed by the law  
4 firm of Best Best & Krieger LLP (“BBK”), attorneys of record for Respondent and Cross-  
5 Complainant, City of Buenaventura (“CITY”) in the above-entitled action (“Action”).

6 2. I have been a paralegal in California for more than 21 years and have held various  
7 positions in two of California’s largest and most historic public law firms for more than 31 years.  
8 I have been employed by BBK since September, 2010. Each of the facts stated herein is within  
9 my personal knowledge, and I would so testify if called as a witness at any hearing.

10 3. On June 2, 2021 in response to the Judge’s May 10, 2021 order to set an Order to  
11 Show Cause hearing regarding the 77 unserved Roe Cross-Defendants behind gated and fenced  
12 properties, I prepared notices and acknowledgments of receipt along with a full service package  
13 which included the following documents:

- 14 i) Summons;
- 15 ii) Third Amended Cross-Complaint;
- 16 iii) Notice of Adjudication – English; Notice of Adjudication – Spanish;
- 17 iv) Form Answer approved for use by Cross-Defendants;

- 20 vii) City Answer to Channelkeeper Complaint;
- 21 viii) State Board Answer to Channelkeeper Complaint;
- 22 ix) Notice of OSC Hearing re Publication;
- 23 x) Ex Parte Application for Order for Publication and supporting documents; and
- 24 xi) A self-addressed, stamped envelope for the Notices and Acknowledgment of  
25 Receipt to be returned in.

1           4.       On May 19, 2021 overnight mailing packages were prepared upon my supervision  
2 and direction for each of the 77 unserved Roe Cross-Defendants and picked up for delivery by  
3 UPS. A true and correct copy of the names and addresses of the 77 unserved Roe Cross-  
4 Defendants is attached hereto and incorporated herewith as Exhibit A.

5           5.       On May 20, 2021, I received via UPS tracking emails, the attached proof of  
6 delivery on 77 Cross-Defendants. True and correct copies of the proofs of delivery receipts from  
7 UPS for each of the 77 unserved Roe Cross-Defendants are attached hereto and incorporated  
8 herewith as Exhibit B.

9           6.       On June 2, 2021 overnight mailing packages were prepare upon my supervision  
10 and direction for an addition 15 unserved Roe Cross-Defendants and picked up for delivery by  
11 UPS. A true and correct copy of the names and address of the 15 additional unserved Roe Cross-  
12 Defendants is attached hereto and incorporated herewith as Exhibit C.

13          7.       On June 3, 2021, I received via UPS tracking emails, the attached proof of delivery  
14 on 14 Cross-Defendants. True and correct copies of the proofs of delivery receipts from UPS for  
15 each of the 14 unserved Roe Cross-Defendants are attached hereto and incorporated herewith as  
16 Exhibit D.

17          8.       On June 9, 2021 I received a telephone call from the UPS delivery driver who  
18 indicated that the overnight package for Mike Marietta, Trustee of the Mike Marietta Living  
19 Trust, Roe 149 was undeliverable due to not having an access code to the fence on the property.  
20 Despite being told to leave the package, UPS returned the mailing. A true and correct copy of the  
21 email notification from UPS is attached hereto and incorporate herewith as Exhibit E.

22          9.       On June 11, 2021 I caused a duplicate package to be delivered via Federal Express  
23 for Monday, June 14, 2021 to Mike Marietta, Trustee of the Mike Marietta Living Trust, Roe 149.  
24 A true and correct copy of the delivery receipt from Federal Express for Mike Marietta, Trustee  
25 of the Mike Marietta Living Trust, Roe 149 is attached hereto and incorporated herewith as  
26 Exhibit F.

27          10.       As of the date of this Declaration 20 Notices of Acknowledgment of Receipt have  
28 been returned to our office bringing the number of unserved Cross-Defendants to 72.

1           11.     As of the date of this Declaration, the unserved Cross-Defendants that were sent  
2 notices and acknowledgments of receipt through this order to show cause proceeding have 20  
3 days in which to return their signed notices. Two days were added to this date to accommodate  
4 service via overnight delivery, making a response due on the 22<sup>nd</sup> day which for 77 packages  
5 delivered on May 20, 2021 was Friday, June 11, 2021 and for the 14 delivered on June 3, 2021 is  
6 Friday, June 25, 2021. Mike Marietta, Trustee of the Mike Marietta Living Trust, Roe 149 will  
7 have 22 days in which to return the signed Acknowledgment of Receipt, or until Tuesday, July 6,  
8 2021

9           12.     If further Notices and Acknowledgment of Receipts are received after the  
10 Proposed Order is signed, the City shall remove those Cross-Defendants prior to publication.

11           13.     Upon expiration of the 22<sup>nd</sup> day after overnight delivery, I shall cause to have the  
12 signed order, if approved by the Court, submitted to the *Ventura County Star* to start publication  
13 of any remaining unserved Roe Cross-Defendants that have been served through this order to  
14 show cause proceeding and promptly submit to the Court the proof of publication pursuant to  
15 code.

16           14.     The *Ventura County Star* is a newspaper of general circulation published and  
17 distributed in Ventura County, where the Property is located, and which is most likely to give  
18 actual notice of the pendency of the proceedings herein to the unserved Roe Cross-Defendants.

19           I declare under penalty of perjury under the laws of the State of California that the  
20 foregoing is true and correct, and that this declaration was executed on June 15, 2021, at  
21 Stockton, California.

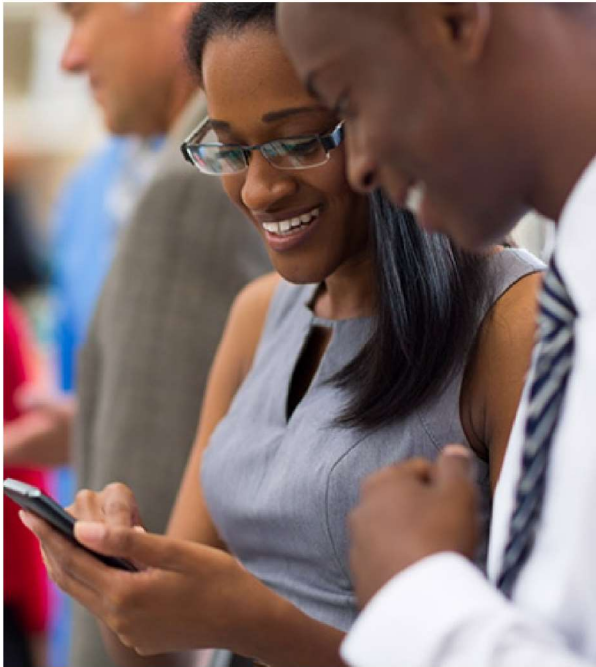
