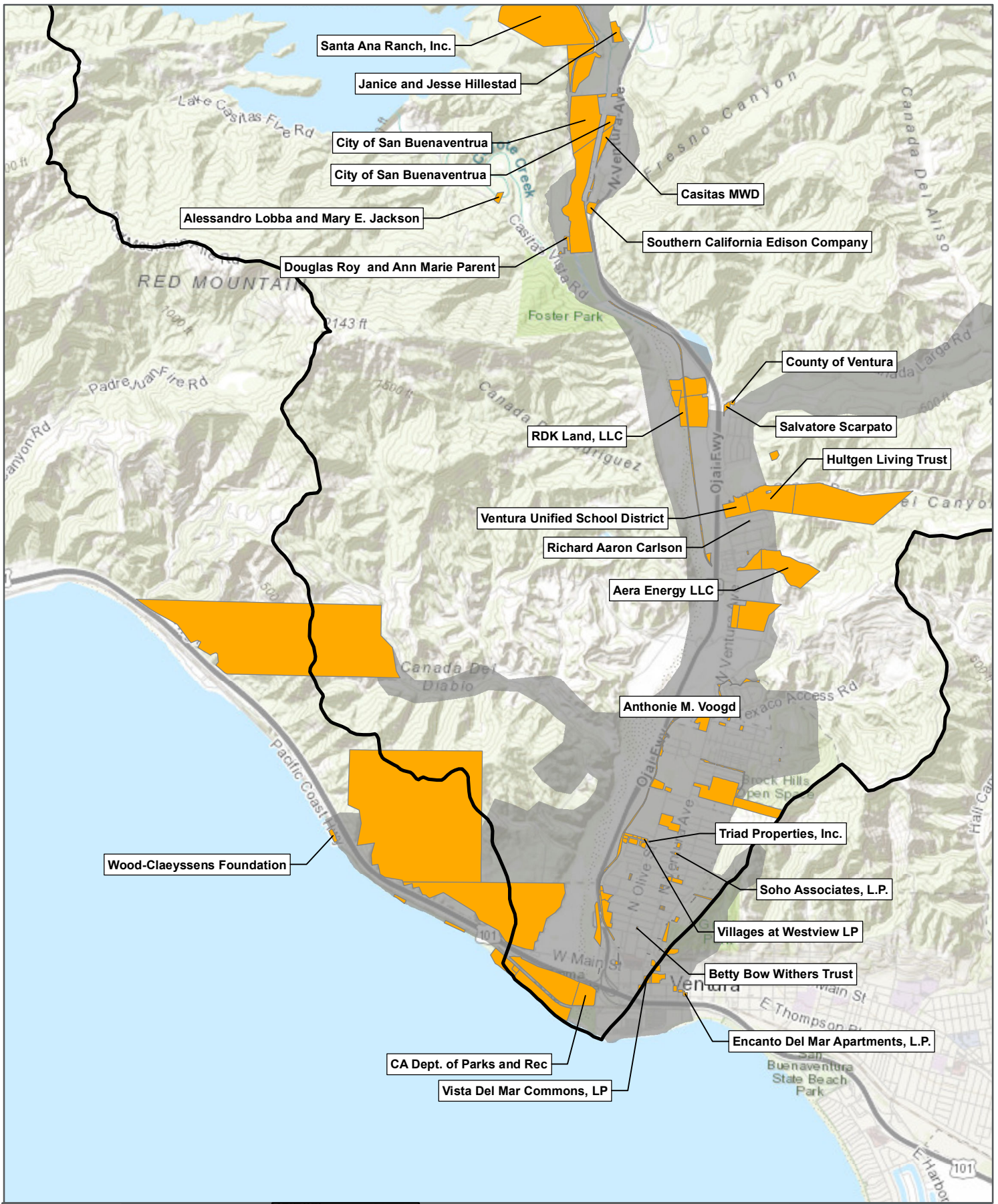

- Groundwater Basin

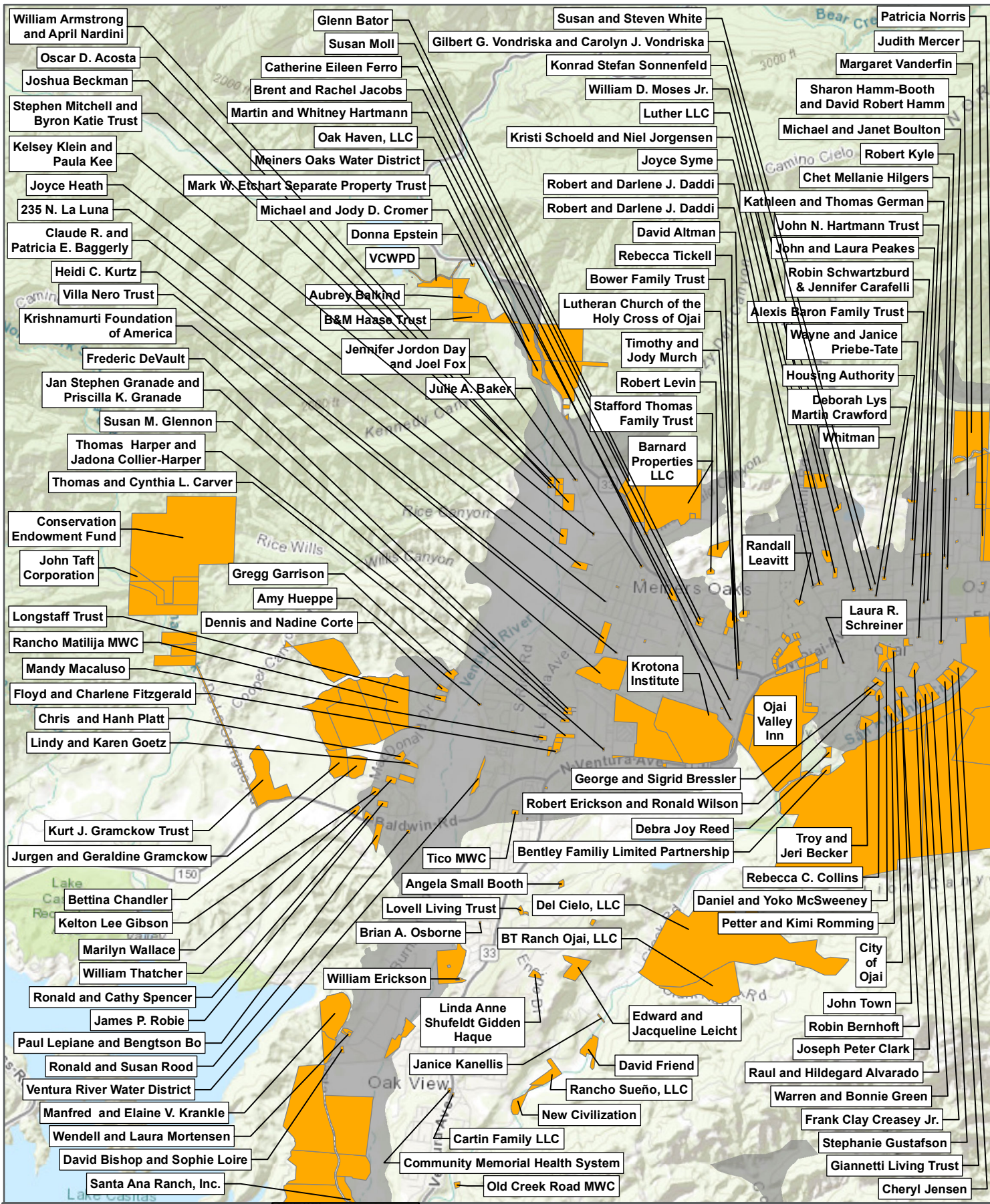

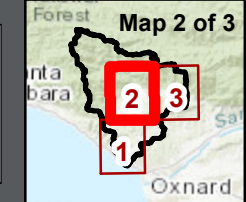
