

PROPOSED ORDER

The Court held a Status Conference on February 27, 2020, at 1:45 p.m. The parties stated their appearances on the record. After consideration of the papers filed in connection with the Status Conference and discussions with counsel, the Court ordered that (1) all Cross-Defendants named in the Third Amended Cross-Complaint ("Complaint") and served with a summons shall have an extension until September 08, 2020 to respond to the Complaint; (2) all persons or entities who received the Complaint, Notice of Commencement of Groundwater Basin and Watershed Adjudication, and Form Answer via mail service shall have an extension until September 08, 2020 to file and serve a Form Answer, if they choose to appear; and (3) City of Ventura has a 60-day extension of time to file proofs of service of the Complaint.

IT IS HEREBY FURTHER ORDERED that:

- 1. Named Cross-Defendants who have not yet filed a responsive pleading may elect to file and serve a "Court-Approved Answer for Cross-Defendants Named in City of San Buenaventura's Third Amended Cross-Complaint," attached hereto as Exhibit A;
- 2. All parties who have appeared shall have a six month extension of time to provide initial disclosures;
- 3. Cross-Defendants filing a Stipulation for Disclaimer must pay a \$20 stipulation and order filing fee, but no \$435 first appearance filing fee is required; and
 - 4. File&ServeXpress is ordered to allow pro per accounts be permitted in this matter.
