DECLARATION OF MARNIE PROCK IN
SUPPORT OF APPLICATION BY CITY OF

1 I, Marnie A. Prock, declare and state as follows:

2
3 1. I am over the age of eighteen years and a senior paralegal employed by the law
4 firm of Best Best & Krieger LLP (“BBK”), attorneys of record for Respondent and Cross-
5 Complainant, City of Buenaventura (“CITY”) in the above-entitled action (“Action”).

6 2. I have been a paralegal in California for more than 21 years and have held various
7 positions in two of California’s largest and most historic public law firms for more than 31 years.
8 I have been employed by BBK since September, 2010. Each of the facts stated herein is within
9 my personal knowledge, and I would so testify if called as a witness at any hearing.

10 3. On June 23, 2021 in response to the Judge’s June 21, 2021 order to set an Order to
11 Show Cause hearing regarding the 78 unserved Cross-Defendants, I prepared notices and
12 acknowledgments of receipt along with a full service package which included the following
13 documents:

- 14 i) Summons;
15 ii) Third Amended Cross-Complaint;
16 iii) Notice of Adjudication – English; Notice of Adjudication – Spanish;
17 iv) Form Answer approved for use by Cross-Defendants;
18 v) ADR Package;
19 vi) Channelkeeper Complaint;
20 vii) City Answer to Channelkeeper Complaint;
21 viii) State Board Answer to Channelkeeper Complaint;
22 ix) Notice of OSC Hearing re Publication;
23 x) Ex Parte Application for Order for Publication and supporting documents; and
24 xi) A self-addressed, stamped envelope for the Notices and Acknowledgment of
25 Receipt to be returned in.

1 4. On June 23, 2021 overnight mailing packages were prepared upon my supervision
2 and direction for each of the 78 unserved Cross-Defendants and picked up for delivery by UPS or
3 sent via United States express mail. A true and correct copy of the names and addresses of the 78
4 unserved Cross-Defendants is attached hereto and incorporated herewith as Exhibit A.

5 5. On June 24 through June 25, 2021, I received via UPS tracking emails or United
6 States postal service, the attached proof of delivery or exceptions on 78 Cross-Defendants. True
7 and correct copies of the proofs of delivery receipts or exceptions from UPS or United States post
8 office for each of the 78 unserved Cross-Defendants are attached hereto and incorporated
9 herewith as Exhibit B.

10 6. On June 23, 2021, I performed further research as to the unserved Cross-
11 Defendants who were believed to be deceased with no known successors. Upon review of that
12 further research, we were able to ascertain the following:

13 (a) one property was found to have recently sold to a new owner. Such
14 deceased cross-defendant will be dismissed and the new owner will be named;

15 (b) two properties have been tax defaulted for several years with a notice of
16 power to sell having been recorded and apparently no sale occurring;

17 (c) one property is reported as abandoned but further efforts on service were
18 undertaken at an address in Miami, Florida to no avail;

19 (d) three potential probate actions were found for one property owner and
20 records ordered to ascertain and identify whether the probate action is for the correct individual
21 owning property in Ventura County;

22 (e) nothing was discovered for one property owner either in property records,
23 probate searches or TLO searches.

24 Out of an abundance of caution, the City will roe in the heirs and devisees for those
25 property owners believed to be deceased and request the Court issue an order for publication as to
26 the heirs and devisees. The City believes the ex parte application will be filed within the first few
27 weeks of July requesting an order for publication on the heirs and devisees.
28

7. On June 24, 2021, I caused to have a duplicate packet of service papers personally served one property owner, John Taft, in Montana and one property owner in Florida, Louis Price. In addition, I sent via overnight delivery a service package to the same addresses. The Florida service on Louis Price was without success. On June 24, 2021, I requested First Legal to perform a skip trace on Mr. Price. On June 28, 2021, I was informed the skip trace produced no new evidence except a moving violation which occurred in Ventura County.

8. As of the date of this Declaration there have been no Notices of Acknowledgment of Receipt returned to our office.

9. The unserved Cross-Defendants that were sent notices and acknowledgments of receipt through this order to show cause proceeding have 20 days in which to return their signed notices. If any Notices and Acknowledgment of Receipts are received after the Proposed Order is signed, the City shall remove those Cross-Defendants prior to publication.

10. Upon expiration of the 22nd day after overnight delivery, I shall cause to have the signed order, if approved by the Court, submitted to the *Ventura County Star* to start publication of any remaining unserved Roe Cross-Defendants that have been served through this order to show cause proceeding and promptly submit to the Court the proof of publication pursuant to code.

11. The *Ventura County Star* is a newspaper of general circulation published and distributed in Ventura County, where the Property is located, and which is most likely to give actual notice of the pendency of the proceedings herein to the unserved Cross-Defendants.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct, and that this declaration was executed on June 28, 2021, at Stockton, California.


